1. ASBOG – Updates – Henthorne

Mr. Henthorne is no longer serving as a member of the National Executive Committee for ASBOG.

2. CLARB – Updates – McMullen

Ms. McMullen reported she recently completed a survey and elicited survey participation for CLARB to assess possible points of friction between new licensees, CLARB, and state licensure boards. Ms. McMullen continues to participate in CLARB webinars and track progress towards the upcoming changes in CLARB government that will affect regional appointments. Mrs. McMullen will be attending CLARB's annual conference in Canada in September 2018.

3. NCARB – Updates – Mancini

Mr. Mancini reported his recent attendance at the regional summit held in Wichita, KS in March 2018 with Board member Mr. Laurino and Executive Director Ms. Lopez, at which NCARB's draft resolutions were reviewed in advance of the annual business meeting. Mr. Mancini reviewed new elected officers in region 5

and previous Board member Mr. Hoffman's upcoming NCARB presidency. Mr. Mancini will attend the June 2018 NCARB annual meeting with other Board members and staff to show Board support for Mr. Hoffman.
