I. MINUTES

By motion of Mr. Wimmer, seconded by Ms. McMullen, the Committee voted to approve the minutes of the April 28, 2017 meeting.

II. APPLICATIONS

- A. Discussion of applications not approved by letter ballot
 - 1. Ballot 17-172 Architect License by Reciprocity Mancini
 - a. Anthony Butler Discipline

By motion of Mr. Mancini, seconded by Mr. Henthorne, the Committee voted to approve the application for Architect License by Reciprocity.

- 2. Ballot 17-192 Architect License by Reciprocity Mancini
 - a. Lindsay Works Discipline

By motion of Mr. Mancini, seconded by Ms. McMullen, the Committee voted to approve the application for Architect License by Reciprocity.

III. UNFINISHED BUSINESS

A. Revisions to Architect Regulations K.A.R. 66-9-7, K.A.R. 66-10-1, K.A.R. 66-10-3

The Committee noted the resubmission of K.A.R. 66-9-7, 66-10-1, and 66-10-3 to the Department of Administration after initial disapproval.

B. New Program Degree Proposal - Bachelor of Science in Interior Architecture and Design, School of Architecture, Design and Planning – The University of Kansas

The Committee discussed the eligibility of professional licensure for a graduate with a B.S. in Interior Architecture and Design upon successful completion of a NAAB-accredited Masters of Architecture degree. K.S.A. 74-7019 and K.A.R. 66-9-1 were reviewed.

IV. NEW BUSINESS

- A. Society updates/reports of national meetings or committees/discussion of national issues
 - ASBOG Updates Henthorne

Mr. Henthorne reported upcoming attendance at association meetings in August and October 2017.

2. CLARB – Updates – McMullen

Ms. McMullen reported her continued participation in quarterly webinars and shared results from "early path to licensure" degree programs that are showing a higher exam pass rate for students who take their exams quickly after graduation rather than following the traditional path to licensure.

3. NCARB – Updates – Mancini

Mr. Mancini shared updates from the June 2017 conference including new progress on IPAL approved schools and growing attendance in the program, Mr. Hoffman's election to First Vice President/President-elect, and his own election to the Model Law Task Force which will have its first meeting in August 2017.

B. AIA Intern Titles

The Committee discussed two proposed titles to be used in lieu of the term "intern" as submitted by the American Institute of Architects: "design professional" and "architectural associate". The titles are to be designated for individuals who have earned a NAAB-accredited degree and are participating in NCARB's Architectural Experience Program or are meeting their jurisdictions' experience requirements (*AIA Directory of Public Policies and Position Statements*. (2017). Washington DC: The American Institute of Architects. doi:http://aiad8.prod.acquia-sites.com/sites/default/files/2017-05/Public-Policy-Directory-April2017.pdf).

The Committee determined that it does not endorse the use of at least one of the titles due to a violation of current statute or rule;

By motion of Mr. Mancini, seconded by Mr. Wimmer, the Committee voted for Kansas to remain a state in which the title "design professional" and/or "architectural associate" violate state laws or rules.

C. CLARB Model Law Revisions

Ms. McMullen reported progress made by CLARB on Model Law and Model Regulations including recognizing public members on regulatory boards, board jurisdiction over unlicensed practice, and election during board member vacancies.

V. CORRESPONDENCE

A. James Rogers- Request for Exemption to Continuing Education Requirements

By motion of Mr. Henthorne, seconded by Mr. Wimmer, the Committee voted to disapprove James Rogers' exemption request, instead granting a 120-day grace period for Mr. Rogers to obtain the required amount of continuing education credits necessary to renew his license. Mr. Rogers is to be notified of the grace period via written correspondence provided by the Assistant Director, to include the KSBTP Computation of Credit Chart.
