
NEW LOOK FOR ONLINE RENEWAL PROCESS

Licensees are seeing a new look for renewal of their licenses for the Board of Technical Professions. A new database has been implemented at the Board office to make licensing and renewals more secure for licensees. The new renewal process allows the licensee to renew in much the same way as done previously with some minor changes for logging into the secure system.

NOTE:

- 1. You will **not** have a user name and password. You must register first with the renewal ID and registration code included in your renewal letter.
- 2. Only enter in the renewal ID and registration code on the "Register a Person" page. If it says it can't find you, you have probably entered too much information.

Turn over your renewal letter for step-by-step instructions on registering your license.

Disciplinary Action Taken by the Board

IN THE MATTER OF DBI, INC

Summary: In late 2013 the Kansas State Board of Technical Professions received an inquiry regarding a website maintained by DBI, Inc. which offered certified crane inspections and consulting services. Included on the website was a statement that "DBI offers load testing, engineering and certification" of certain items, as well as "lifting devise engineering and certification." At the point in time when these assertions appeared on DBI's website, it was not licensed in Kanas to practice engineering nor did it hold a certificate of authorization allowing it to do so.

Board Action: The Board and DBI, Inc. resolved this matter by way of Settlement Agreement and Consent Order which contained the following terms of settlement: 1) DBI, Inc. shall immediately cease and desist from practicing, offering to practice or holding itself out to practice the technical profession of engineering in Kansas until such time as it has obtained a certificate of authorization to do so. 2) DBI, Inc. shall immediately cease and desist from referring to itself as an engineer or engineering firm, or from using the term in the State of Kansas until such time as it has obtained a certificate of authorization to do so. 3) DBI, Inc. shall, on or before July 1, 2014, cease and desist from using any letterheads, business cards, websites or any advertisements including telephone book listings which refer to it as an engineering firm or providing engineering service.4) DBI, Inc. shall pay a fine and Board costs in the amount of \$500.00 incurred in the prosecution of the matter.

Status: The fine and costs required by the Settlement Agreement and Consent Order have been paid in full.

Architects & Geologists

All Architects and Professional Geologists whose last name begins with the letters M-Z will be sent a notice of renewal in early May. These licenses expire on June 30, 2015. You can renew online from the Board's website, www.ksbtp.ks.gov, under the Renewals tab. The biennial renewal fee is \$60. (Those over 70 years of age are \$5.)

You may search by name, license number, City, State, Profession, even County. This feature may provide confirmation of a license, the status of a license, a document to provide proof of licensure, or a list of professionals in your geographic area. Continuing Education Audits

What happens if you receive a renewal notice that indicates you have been selected for an audit of your continuing education hours?

Follow the instructions concerning submitting your documentation to the Board. **REMEMBER**, your license will expire on the listed expiration date. To insure that your license remains in effect, submit your renewal form and audit documents before the expiration date.

The 'clean-up bill' for minor revisions to statutes for the Kansas State Board of Technical Professions is currently working its way through the legislative process. The bill is HB Substitute 2224, previously SB24.

Kansas State-Specific Exam Committee Meets

The Kansas Board's State-Specific Surveying Exam Committee met recently in Topeka. The committee is made up of Professional Surveyors from different practice backgrounds and geographic areas of the State. The committee meets periodically to review the appropriateness of the materials and syllabus of the State-Specific Exam which is one of the exams required for licensure as a Kansas Professional Surveyor. The group reviews each question in the bank of exam questions and writes new questions. "The Board appreciates the time and dedication of this group," said Board Member Tim Sloan, PS. "The Board's purpose is to make the exam complete, fair and appropriate and to assure competence in those whom we license. This group helps the Board achieve that goal."

Many years ago the Committee identified seven subject areas which are examined on the State-Specific Exam. A few years ago the Board split the exam into two parts. Part I tests on Minimum Standards, Kansas Statutes and Rules, state plane coordinates and riparian boundaries. Part II tests on the original GLO system, resurveys on the system, and calculation problems related to the reestablishment of lost corners. Each part is a one-hour exam. The committee reviewed the percentage of the exam that covers each of the subject areas and made a recommendation to the Board, which it subsequently approved. The percentages for each subject area are:

Part I, General (One hour) Exam

Minimum Standards 54% Statutes and Rules 29% State Plane Coordinates 10% Riparian Boundaries 7%

Part II, The U.S. Public Land Survey System (One hour) Exam

Original GLO 33% Resurveys on the USPLSS 33% Calculation Problems, USPLSS 34%

These percentages will be used beginning with the October 2015 Exam.

NEW EMERITUS STATUS & INACTIVE STATUS

An update to K.S.A. 74-7025 for the Kansas Board of Tech- INACTIVE status for a Kansas license with the Kansas nical Professions provides for a newly created *Emeritus* status for licensees. This status can be selected at the time of renewal or upon notification of the Board Office. The *Emeritus* status form is available on the web page at: http://ksbtp.ks.gov/docs/default-source/default-documentlibrary/ksbtpemeritusapp11-2014.pdf?sfvrsn=2

Board of Technical Professions has replaced the retired status previously used.

For more information on the INACTIVE status, which reguires no continuing education but also means that a licensee cannot practice the profession in Kansas, please call the Board Office at 785-296-3053.

K.A.R. 66-6-10(c) states: "Emeritus status shall require the individual to be at least 60 years of age. The individual shall submit a one-time application, with no fee and no proof of continuing education required. The individual shall have no pending disciplinary action before the board. Any individual who chooses this license status may use that individual's professional title in conjunction with the word "emeritus." The individual shall not practice a technical profession in Kansas." This includes practicing the profession in any capacity including as a consultant. (SAMPLE: John J. Doe, P.E., *Emeritus*)

NCARB Regional Summit Meeting Report March 12-14, 2015

In preparation for the upcoming annual NCARB meeting in June, board member Vince Mancini, AIA, and KSBTP Executive Director Mary Leigh Dyck, attended the NCARB Regional Summit in Long Beach, California this past March. Dave Hoffman FAIA, Kansas Architect Board Member was also in attendance representing NCARB Region 5 (Kansas, Montana, Nebraska, North Dakota, Oklahoma, South Dakota and Wyoming), on the NCARB Board of Directors. Dave has also announced his candidacy for the position of Treasurer on the NCARB Board.

There are 6 regions within NCARB and this year member board members and member board executive directors from each state met to review and discuss resolutions that will be voted upon during the Annual NCARB June meeting. There were 52 of the 54 member boards represented at the Long Beach NCARB Regional Summit.

Member Board Executive Director Mary Leigh Dyck attended the MBE workshop on March 12 which included Roundtable Discussions regarding current issues facing licensing boards.

During the meeting there were presentations from NCARB on activities this past year and committee updates. Also we learned more information about the following proposals:

- The proposal to "Streamline" the IDP required hours for "Experience Areas" will be moving forward. Focus will be on the IDP's
 core requirements and elective hours will no longer be required. The current "Experience Areas" will be condensed into 6
 "practice—based" areas to correspond with future ARE 5.0
- 2. ARE 5.0 is expected to launch in late 2016. NCARB will soon announce information about dual delivery of both ARE 4.0 and 5.0 date and the Transition to ARE 5.0.

During the Region 5 meeting we reviewed the 2015 draft resolutions "A" thru "C" to be voted upon at the annual meeting in June. These proposed resolutions may be viewed on the NCARB web site where a fuller explanation of each resolution can be found. They are titled:

A. Revision of the Alternatives to the Education Requirement for Certification:

This proposal is intended to ensure that each applicant documents the experience necessary to overcome the deficiencies associated with their education by requiring additional hours in each of the categories and areas of the Intern Development Program; recognizes the value of practical experience; and encourages intern architects to obtain an architectural degree in an accredited program to avoid having to complete multiple additional years of experience through the IDP.

B. Revision of the Requirements for Certification of Foreign Architects:

This proposal is intended to ensure that each applicant documents the pertinent experience necessary for competence to practice in the U.S. in each of the categories and areas of the IDP; ensures that the foreign architect clearly demonstrates his/her understanding and ability to practice independently in the U.S. and recognizes the importance of applying similar standards for licensure for all who wish to practice in the U.S.

C. Bylaws Amendment – Modification to the Qualifications of Public Director on NCARB Board of Directors.

This proposed Bylaws change reflects the desires of the Public Member Task Force to utilize the skills and knowledge obtained regarding protection of the public health, safety and welfare through service on a Member Board by enabling a public member currently serving on an NCARB Member Board to apply for and serve as the Public Director on the NCARB Board of Directors.

Additional information on each Resolution will be reported after the annual meeting in June.

Region 5 Director Dave Hoffman gave a report on NCARB activities at the Board of Directors level for the past year. Dave also spoke about his announced candidacy for the Treasurer position on the NCARB Board of Directors. He mentioned the treasurer's role in monitoring, reporting and measuring costs for the Board, as new programs develop and emerge with NCARB's three Strategic Goals, for "Facilitating Licensure", "Fostering Collaboration" with Member Boards and collateral organizations' and "Centralizing Data" for Member Boards.

Candidates for other NCARB Board of Director positions also spoke at our meeting. Election will be held during the June Annual Meeting.
